Dear Parents, Friends & Patrons of  
Heartland Community Schools,

The 2011-2012 school year is off to a good start. We are excited about what the new year will bring. We look forward to interacting with as many of you as possible during the school year.

The new valuation figures are in and the board has adopted the 2011-2012 budget. The valuation for the district has increased by 16.3% which raised the district valuation from 371,105,539 to 430,947,322. This increase is by far the largest valuation increase in the district in the past 30 plus years. With this type of increase, the board was able to lower the current tax levy from \$1.05 to \$.96517. The current levies are as follows: General Fund: \$.91947, Special Building Fund: \$.03164, and the Qualified Capital Purposes Undertaking Fund: .0184, for a total levy of \$.969517. The total General Fund Budget increased by 3.2% to a total of \$5,957,735. The board decided to establish a Special Building Fund to help with the cost of replacing the heating and air conditioning units in the theater. The revised cost for the heating and air conditioning replacement is in the neighborhood of \$300,000. In addition to the Special Building Fund, funds will come from the General Fund as well as the Depreciation Fund.

I can assure you the board and administration put a lot of time and effort into developing the total budget. The board is very conscious of the financial impact taxes have on the patrons of the school district. If the combined general fund and Special Building Fund levy drops below \$.95, the district loses dollar for dollar in state aid. If you have any further questions about the budget, please give me a call or feel free to stop in at the office.

I would also like to take this opportunity to congratulate the current school board members for their recognition at the recent District Nebraska Association of School Boards District Meeting in York. The board was again recognized as an Outstanding Board for their commitment to self improvement by attending numerous in-service activities for school board members during the past year. The current school board members are Paul Brune, President, Gary Braun, Vice President, Deb Wilhelm, Secretary, Boyd Stuhr, Treasurer, Kent Allen, and Glenn Larson.

I hope each and every one of you will do all you can to encourage Heartland students to do their very best to be all they can be in both academics and activities.

### NEW STATE REQUIREMENTS ON IMMUNIZATIONS



As of July 1, 2011, the State of Nebraska School Immunizations Rules and Regulations state that all students, grades Kindergarten through 12th, must have two doses of the Varicella (chicken pox) vaccine. Last winter we reviewed all our records and sent letters to those students who did not meet this requirement. We have also been calling those that are still missing this shot information. Please provide the school office with a copy of your child's immunization records with a date that this vaccine was received or a date that your child has had the chicken pox disease.

**If we do not have this information by October 17th, 2011, your child will not be able to return to school until they have received this vaccine.**

With the HIPAA laws in affect, we cannot obtain this information, only A parent or legal guardian may. Thank you for your help and cooperation with this matter.

### PARKING IN FRONT OF THE SCHOOL

Please do not park in the area that is marked with yellow curbs in front of the school during school hours. This is particularly true before and after school. It is all right to use it for pick-up and drop-off of students, but it creates a real safety issue when you block the way for busses and other parents when you park in that area.

We also ask that you allow room for bus parking in these areas during school activities. This area is reserved for busses from visiting schools to park.

We appreciate your cooperation for the safety of our students!

### SCHOOL CLOSING INFORMATION

As the winter approaches, occasional bad weather necessitates the closing of school for the safety of our students. School closing information will be announced over the radio station KAWL (1370) and television stations KHAS, KLKN, NTV and KOLN. In Henderson it will be announced with voiceover capabilities on any cable channel (in town) when your TV is on. We have implemented an automated phone message service through School Reach which we will use for school closings as well. You may also call our school closing phone line at 402-723-4421. If a decision has been made the night before, the closing will be announced at 10:00PM. In the mornings it will be announced on the half hour from 6:30AM to 8:00AM (cable only).

### **HEARTLAND FFA HOLDS ANNUAL SAFETY DAY**

The Heartland FFA Officers consisting of: Rick Siebert, Brenan Erb, Brielle van den Berg, Andrew Spader, Miranda Janzen, Daniel Quiring, Morgan Tracy, Matthew Hiebner and Brent Regier, recently held their annual Safety Day. Heartland students from grades 3<sup>rd</sup> - 6<sup>th</sup> were invited. The afternoon consisted of four different sessions. These sessions were run by the FFA officers and Four Corners Health Department. The four sessions consisted of ATV Safety, Bicycle Safety, Poison Control and Making Safety Kits. During the ATV Safety session, students learned how to safely operate an ATV and answered questions regarding ATV safety. At the Bicycle Safety session, students filled out a crossword on bike safety and also watched a power point about bike safety. The Poison Control session, led by Four Corners Health Department, taught students about different poisons and what action to take if poisons are consumed. At the final session students filled, colored, decorated and built their own safety kits. After all the sessions, students received a treat from the Heartland FFA Officer team.

### **SCHOOL SAFETY – PLEASE SIGN IN**

School safety is an extremely important part of Heartland Community Schools. We want all of our students to feel safe when they are at school and on school transportation. We stress safety with our school bus drivers and with our teaching staff. One important aspect of our school safety plan is to have all visitors sign in at the office when they are in the building. We don't anticipate anything happening, but we want to be prepared and keep the building safe. For this reason, we ask that all visitors please sign in at the office and pick up a pass. We do recognize the majority of people that come in the building, but it is very difficult to say that some visitors need to have a name tag, and some do not. Therefore, we want to emphasize that all visitors must sign in and pick up a name tag. Staff persons are asked to remind THOSE without a name tag to please remember to stop by the office and pick one up. We ask your cooperation in helping the school staff to help make Heartland a very safe place for our students. We are looking at ways to make this process as simple as possible and one of the ways might be to have you sign in on a computer rather than on paper. Thanks for your cooperation.

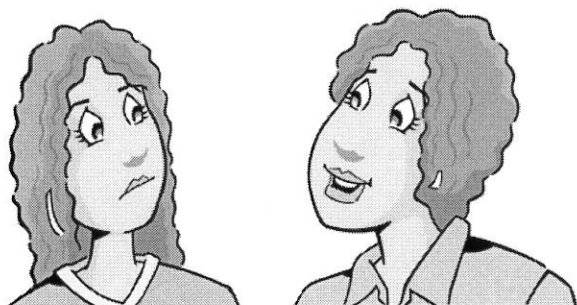
#### **Keep your child motivated in school all year!**

It's too early in the school year for your middle schooler to have a ho-hum attitude about class! Instead, he should be looking forward to the months ahead.

You can help him do just that, and keep him motivated, if you:

- **Let yourself be "wowed."** Do you give off a "been there, done that" vibe when your child tells you about something he's learning in school? Stop! A fact or idea may not be new to you, but if it's new to your child, show some enthusiasm. "Your science teacher poured liquid nitrogen on a flower and it froze? Just like that? How cool!"
- **Celebrate small victories.** Yes, scoring 100 percent on a math test is a reason for high-fives all around. But so is a solid B on a history project your child worked hard on. Show him that you notice the effort he's putting in, and it may motivate him to keep trying his best. Only congratulating your child for A's may squash his enthusiasm by causing him to think, "Why bother trying at all if only 'perfect' matters?"

#### **Do you know how to handle your child's difficult behavior?**

Part of early adolescence involves leaving childhood behind and separating from parents. Another part involves answering questions such as: Who am I? What do I believe? As your child goes through this she may display some difficult and defiant behavior, even if she has never done so in the past.

For many middle school children, this means talking back to parents. Here are some guidelines for handling this behavior:

- **Resist the urge to argue back.** Instead, show your child who the adult is. Practice calm kindness in the

face of her rudeness. For example, say "You sound pretty upset. I'm sorry to hear this. When you calm down, I'll be happy to help if I can."

- **Continue to set limits.** Some back talk is developmental. But there are some things you should never tolerate, such as profanity directed at you or another person. If this happens, give your child a choice: She may go to a quiet place to think until she is ready to apologize. Or she may lose a privilege.
- **Enjoy the flip side of your child's arguing.** When she is calm and happy you can have great conversations. Your child's new ability to argue actually reflects a growth in her ability to reason. She can now discuss things at a higher level than she could in elementary school.

#### **Teach your middle schooler the many ways to show respect**

We all want respect. When someone respects us, they act and speak in a way that shows us we are worthy. Our actions and opinions are valid and important, even if the other person does not always agree with them.

There are many ways to show respect. Teach your middle schooler that respect is:

- **Believing in yourself.** Respect begins with self-respect. Act in a way that does not leave you disappointed in yourself.
- **Controlling yourself.** Outbursts and rudeness are completely disrespectful--both to the person with you and to yourself.
- **Listening to and being polite** to persons in authority. This includes teachers and parents.
- **Realizing that learning is important.** It is a way to better yourself.
- **Realizing that you have** something to learn from almost every person you meet.
- **Being on time.** If you want to show respect for someone, show respect for their time.
- **Being someone others can trust.** Do what you say you will do.
